#### 1. Conditions of carriage

- The present "Conditions of carriage" apply to all sales of air cargo departing from countries other than Italy by or on behalf of Italia Trasporto Aereo S.p.A. ("ITA-Airways") and are valid from 29 October 2023. The Conditions of transport specify the booking conditions and operational requirements which apply to the above-mentioned sales and may be modified by the Carrier at any time with an immediate effect. We invite you to check regularly for updates with our offices before making a new booking.
- All bookings for air cargo transportation imply full acceptance of the Conditions of transport by the shipper or its representative agent.

#### 1.1 Rates

- "All in rates" for air cargo transportation are based on the booking information and do not include applicable taxes, levies, fees and Other Charges (e.g. screening charges, customs, DG handling etc.). ITA-Airways may change or add further charges at any time without prior notice.
- Applicable rates, taxes, duties fees and Other Charges are available: www.ita-airways-cargo.com.
- Customs duties are excluded.
- For all shipments the minimum taxable must be respected.
- Shipments as charge collect are not accepted.
- For goods requiring a special handling Specialized product price list will apply.
- ITA Airways charges a DG Check Fee for all kinds of dangerous goods. The amount charged for the Check Fee depends on the country of origin, the IATA-classification of the goods and the quantity UN-Numbers included in the shipment Dangerous Goods. Shipments that are rejected (not suitable for carriage) and require a second DG check will be subject to a DG Re-Check Fee. For radioactive shipments, a separate Radioactive Fee will be applied on top of the DGR Check Fee.
- For consolidated shipments, if an Ad-hoc rate is not requested, the higher Market rate of the goods in the shipment will be applied to the entire AWB. All Other Charges will also be requested.
- Security Regulations: for shipments not delivered according to local security regulations, an additional Security Fee for screening of cargo may apply. For more details, please contact ITA Airways local sales representative.



- Where applicable VAT must be added to the Weight charge plus other charges published.
- CCA Charge Correction Advice Fee applies to any change to the AWB requested by the customer (sender, consignee, destination, taxation, weight, parcel, etc.) including changes to supporting documentation (temporary export, document visa, ECS, etc.)
- Minimum weights for General cargo ULD:

PMC (Pallet Lower Deck) = 1650kg

LD3 = 750kg

PAG = 1550kg

#### 1.2 Ad hoc Rates (spot)

- Ad hoc rates shall be requested by sending an e-mail to ITA Airways local customer service office.
- Ad hoc quotations have a maximum validity of one week unless otherwise specified by the customer service office.
- The spot reference number for the Ad-hoc rate shall be noted in the accounting information box of the AWB.
- Should there be a discrepancy equal to or lower than 20% between the manifested and booked weight, the Ad hoc rate will no longer be applied, and the market rate will be applied instead.
- BUP (Build Up Pallet) shipments are rated at the pivot weight unless the Actual Weight is higher than the Pivot Weight.

#### 1.3 Booking Information

For AWBs already booked in ITA-Airways system, in the amendments of the following fields is not allowed: Origin, Destination, Agent, Product.

Should any of this fields require a modification, issuance of a new AWB will be required.

It is not possible to consolidate a shipment when the goods are a VAL (for example, Product code Gen with SPCSAF1). It is only possible to combine a shipment with valuable goods.

For invoicing purposes, the weight and volume data collected during cargo acceptance will overwrite the one communicated during the booking phase. Should there be any deviation, ITA Airways reserves the right to apply a CCA fee.

- If the first leg is a RFS (Road feeder service), cancellation or weight change has to be communicated within 72 hours
- For Active Temperature Controlled Containers, the Cancellation Fee applies to orders canceled from 4 days before collection date (for all origins)
- Cancellations and weight changes of shipments must be communicated by e-mail during office hours. For contacts refer to section 2.2 <u>Contact</u>.
- Penalties will be invoiced using the AWB originally issued for the booking (even if partial) through the IATA CASS.



#### 1.5 Demurrage, Damage Fee and Non-Return Value of ULD

The Cargo Agent shall be deemed in charge of the custody of the Unit Load Device (ULD) from the time the ULD is handed over to of delivery and shall be responsible for the failure to comply with the terms of delivery to the release station, for damage and loss of the same. Upon the occurrence of such events, the Agent must pay Ita Airways the following penalties:

- Demurrage Fee: will be charged to the Cargo Agent, as indicated in the table below, based on the number of days ULDs are withheld beyond the 10-day allowed period starting from midnight on the day of release and inclusive of Saturdays, Sundays, and public holidays. The days of partial use will be charged as full day.
- Damage Fee: will be charged to the Cargo Agent, based on what is indicated in the table below and inclusive of repair costs, in cases of structural damage or loss of the ULD. Nets delivered together with the ULD are considered an integral part of the ULD.
- Non-Return Value Fee: will be charged to the Cargo Agent, as indicated in the table below, based on the non-return value if a ULD is not returned within 180 days from midnight on the day of issue or if the same is irreparably damaged.

#### 1.7 Specialized Fresh and Pharma active/passive

- ITA-Airways offers the possibility to lease C-Safe, Dokasch, Sky Cell and Envirotainer containers. The cost of the lease is included in the Specialized Fresh/Pharma Active-Passive price list (available upon request), any additional applicable costs will also be provided at booking time.
- Dry Ice and battery replacement costs are responsibility of the shipper or its agent.
- Pick-up and delivery of the container shall be handled by the client unless otherwise agreed at time of booking.
- Bookings of active and passive containers must be requested within the time limit set for each container type. Booking requests received passed the time limit will be treated as Express and are subject to the payment of an "Express fee".
- Should the booking be cancelled after the container has been picked up by the client, ITA Airways reserves the right to apply a cancellation fee.
- Lost container will be recharged by ITA-Airways to the Cargo Agent in full.



#### 2.0 Acceptance and booking Policy

- Carrier may refuse to carry a shipment if no prior booking has been made or if information provided at booking time is not in accordance with the actual shipment offered for acceptance to the Carrier.
- Cargo must be tendered to ITA-Airways or its Cargo Handling Agent "Ready-for-carriage" in compliance with IATA resolutions and applicable laws and regulations.
- Product Name and code, exact nature of the goods, temperature range and emergency contact number must be noted in the "Handling Information" field of the airwaybill (AWB). In addition, the wording should be inserted: "keep between x and y whenever possible"
- Bookings should be made either by email or telephone using the contact details shown below (point 3) and indicate the air waybill number, the exact weight, volume, and product type.
- Customers must update bookings as soon as underlying shipment details are modified, regarding the weight, volume, or commodity type.
